Village of Horseheads Water User:

We are writing to inform you of an upcoming change in your water rates.

Due to increasing costs in maintenance along with State and Federal mandates and necessary infrastructure improvements; the Village of Horseheads must increase our water rates effective, June 1, 2024. The new Quarterly minimum bill will be \$28.37. Customers outside of the Village minimum bill will be \$42.55. This adjustment is essential to ensure the continued reliability and quality of our water services. Along with the rate increase each account will be billed a \$14/qtr Infrastructure Improvement Fee to cover future costs necessary to stay current with mandates. Please see summary rates below.

ALL OTHER SERVICES:

LABOR/COST OF MATERIALS:

LABOR shall mean the actual hourly rate of all Village personnel involved in providing the service (multiplied by a factor of 2.0 (or a factor of 2.5 if overtime/emergency call out charges are applicable).

COST OF MATERIALS shall mean the current replacement cost of all materials used to provide the service, if any.

Note: Sales Tax to be added to all material charges.

LABOR/COST OF MATERIALS for any service for which the fee is based upon Labor/Cost of Materials there shall be added a charge of 10% of Labor/Cost of Materials for Administration and Overhead.
